JOB ANNOUNCEMENT

Background

The National Agency for PPPs (NAPPP) was established in September 2022 when it received its legal powers and charter from the Ministry of Finance, Economic Stability and National Policies. The primary objective of NAPPP is to support an enabling environment that encourages investment in and the identification of PPP projects that can be implemented in a timely manner by government agencies.

Secondary objectives include NAPPP facilitating projects that will address the national funding gap and aligning PPP projects with national priorities and Sri Lanka's development goals. Additionally, NAPPP will support governance processes in PPP project initiating line ministries (contracting authorities) that ensure project value for money, and that efficient and cost-effective project outcomes are achieved through transparent and competitive procurements.

Ongoing and proposed PPP projects mainly cover transport, highways, water, ports, tourism, ICT, housing industrial zones, minerals and energy sector.

The Ministry of Finance, Economic Stability and National Policies is now seeking to engage Sri Lankan professionals on contractual basis who are suitably qualified and experienced to join the NAPPP.

Job Title: Lead Transaction Advisor (2 Positions)

Responsibilities:

Lead Transaction Advisors will oversee specific PPP transactions and manage and assist transaction teams both internal and external involving the line Ministry together with local and international technical advisors.

Qualifications:

A university degree in the relevant field and recognized by the University Grants Commission and/or professional qualifications such as CIMA/ACA/ACCA/CFA.

Additional tertiary / professional qualifications would be an advantage.

Experience:

Minimum of 10 years' experience in one or more disciplines covering project lending, investment banking, private equity, fund raising and management

Candidates must have negotiating skills and should have been actively involved in private investment appraisal and structuring. Additional responsibilities include supporting the development and review of financial plans and models to determine the commercial and economic viability of PPP projects.

Candidates should demonstrate built and managed international and local corporate relationships and experience working with international donor, investor, and development organizations.

Responsibilities:

The Senior Procurement Officer will support Line Ministry's procurement, management and monitoring of PPP project contracts.

Qualifications:

A university degree in the relevant field and recognized by the University Grants Commission and/or professional qualifications such as CIMA/ACA/ACCA/CFA.

Additional tertiary / professional qualifications would be an advantage.

Knowledge of National Procurement laws, guidance and policy.

Experience:

A minimum of 10 years in government project procurement, risk assessments and contract management. Experience in procurement of projects sponsored by donors and development banks is highly sought, as well as PPP project procurement expertise.

Candidate must also have proven analytical, writing, presentation and interpersonal skills.

Public-Private Partnership (PPP) experience is a strong consideration.

Candidate must also have proven analytical, writing, presentation and interpersonal skills.

Job Title: Senior Project Officer (Legal)

Responsibilities:

The Legal Officer will support Line Ministry's procurement of PPP projects as well as ensuring legal compliance with national laws, policy, and guidance.

Qualifications:

LLB with Attorney-at-law.

Additional tertiary / professional qualifications would be an advantage.

Experience:

The ideal candidate should have at least 10 years' experience in corporate and commercial law, having worked at senior level in a recognized firm of lawyers, having represented reputable local and international corporations in matters relating to procurement contracts, investment due diligence, and institutional restructuring.

Candidate must also have proven analytical, writing, presentation and interpersonal skills.

Public-Private Partnership (PPP) experience is a strong consideration.

Job Title: Project Officer (Research Executive / Analyst)

Responsibilities:

The project officer will support Line Ministry's project related socio-economic research, feasibility analysis, due diligence assessments of projects and compliance, with related national laws.

Qualifications:

A university degree in the relevant field and recognized by the University Grants Commission and/or professional qualifications such as CIMA/ACA/ACCA/CFA.

Additional tertiary / professional qualifications would be an advantage.

Experience:

The ideal candidate should have at least 5 years' experience in socio-economic research and stakeholder outreach.

Candidates must have proven analytical, writing, presentation and interpersonal skills.

Nature of the Appointment: One year contract, renewable up to 03 years based on performance.

How To Apply

Non-government candidates can apply for these positions. Public Sector Officers in service and retired can apply for these positions and they will be assigned on a contract / secondment basis. Age limit is not applicable for public sector officials in service.

Applicants employed in Government Ministries / Departments, State Corporations, Boards & Authorities should send their applications through the heads of their respective organizations.

Short listed candidates will be called for an interview and the candidates will be required to present all originals of relevant certificates at the interview.
